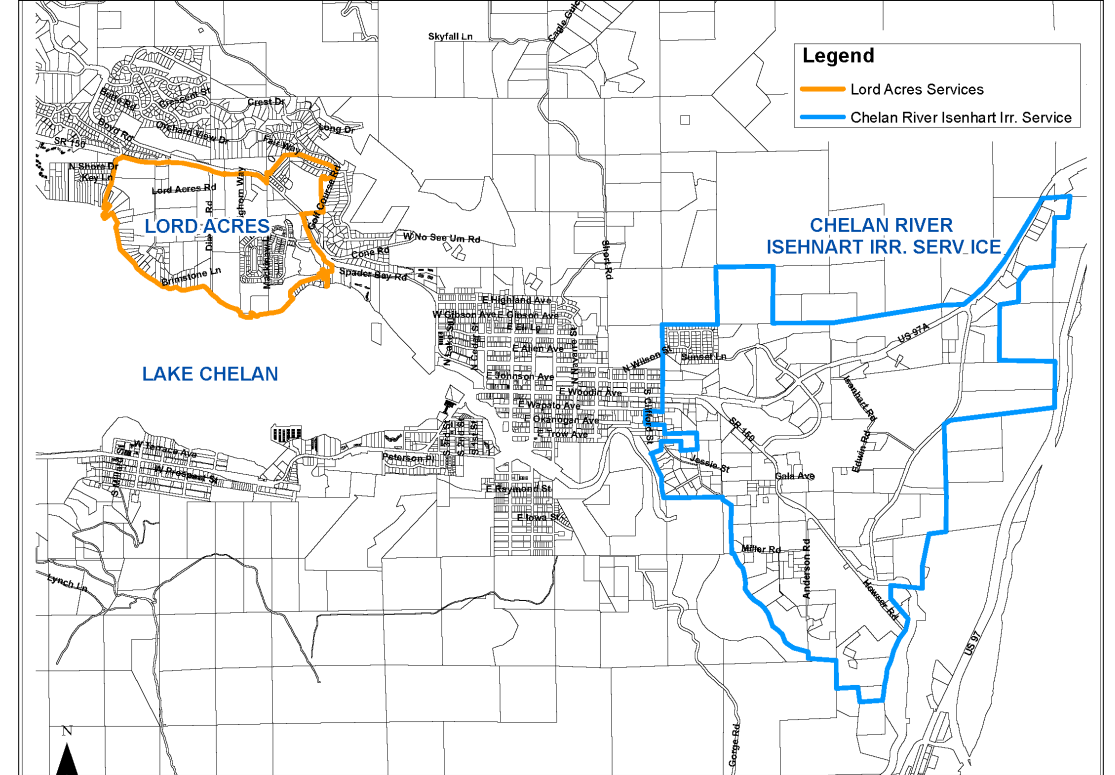

**Inspection Requests Require 24 Hour
Advance Notice**
APPLICATIONS ARE AVAILABLE ONLINE

PERMITS: WHEN REQUIRED

No building, mechanical, or plumbing system shall be construct, enlarged, altered, repaired, moved, demolished, or changed unless a permit has been obtained. Building, mechanical, plumbing, and grading permits may be required.

Please contact your building department regarding questions and further clarification.

Building Permit Fees

Permit Fees - Permit fees are based on the total valuation of the proposed work. The valuation used for the building permit is determined by the Building Official. Valuation of new construction and additions are based on the proposed square footage utilizing building valuation data published by the International Code Council. The most current square foot construction costs are available at www.iccsafe.org.

Plan Review Fees - Plan review fees shall be paid at the time of plan submittal based on 65% of the permit fee. Plan review fees are in addition to permit fees.

Changes or Incomplete Applications - Changes or incomplete plans, documents, or deferred submittals will be required to pay additional permit and plan review fees.

Building Permit Fee Calculations

Total Valuation	Fees
\$1.00 to \$500	\$23.50
\$501 to \$2,000	\$23.50 for the first \$500.00 plus \$3.50 for each additional \$100.00, or fraction thereof, to and including \$2,000
\$2,001 to \$25,000	\$76.00 for the first \$2,000.00 plus \$14.00 for each additional \$1,000.00, or fraction thereof, to and including \$25,000
\$25,001 to \$50,000	\$398.00 for the first \$25,000.00 plus \$10.10 for each additional \$1,000.00, or fraction thereof, to and including \$50,000
\$50,001 to \$100,000	\$650.50 for the first \$50,000.00 plus \$7.00 for each additional \$1,000.00 or fraction thereof, to and including 100,000
\$100,001 to \$500,000	\$1000.50 for the first \$100,000.00 plus \$5.60 for each additional \$1,000.00, or fraction thereof, to and including 500,000

Plumbing Permit Fees

For issuance of each plumbing permit\$20.00
For issuance of each supplemental plumbing permit\$10.00

Add following per item costs to the above plumbing permit fee:

- Each single trap fixture including DWV, water, backflow, or grease interceptors.....\$ 7.00
- Exterior building sewer.....\$15.00
- Water Heater.....\$ 7.00
- Gas piping, add \$1 for ea. add'l outlet >5.....\$ 5.00
- Repairs or alterations to existing plumbing per fixture\$ 7.00
- Lawn sprinklers and meter with backflow.....\$ 7.00
- Gray water system\$40.00
- Medical gas system (add \$5 for each additional outlet).....\$50.00

Other Plumbing Inspections and Fees per hour charges:

- Inspections outside or normal business hrs.\$30.00*
- Re-inspection fee.....\$30.00*
- Additional plan review fee.....\$30.00*
- Deferred Submittals \$30.00*

- Ventilation and Exhaust (single duct).....\$ 7.25
- Boilers, Compressors & Absorption Systems (100,000) BTU.....\$14.70
- Air Handlers (10,000 cu ft per minute).....\$10.65
- Fireplaces (domestic—gas, pellet or wood).....\$18.20
- Repairs and/or Additions.....\$13.70
- Appliance Vents.....\$ 7.25
- Miscellaneous.....\$10.65

Other Inspections and Fees:

- Inspections outside of normal business hours, per hour (minimum charge- two hours)\$45.50*
- Re-inspection fees per inspection.....\$49.50*
- Inspections for which no fee is specially indicated, per hour (minimum charge - one- half hour) \$49.50*
- Additional plan review required by changes, additions or revisions to plans or to plans for which an initial review has been completed (minimum charge of one-half hour).....\$49.50*
- Deferred Submittal\$49.50*
